**Additional time per trial billed at \$125/hr.*

ATTENDANTS/FAMILY

A \$900 minimum fee applies to each wedding

Price includes 4-person minimum - bride, bridal trial, and 3 attendants/family members

In-Studio Bridal Makeup at Tryst

BRIDE

Wedding day in-studio bridal makeup services.....\$200.00

Bride makeup trial (60 minutes*).....\$100.00

**Additional time per trial billed at \$100/hr.*

ATTENDANTS/FAMILY

Attendants/family members' makeup services (per person).....\$95.00

Payment Terms

A retainer in the amount of 50% of the total contracted fees is due upon contract signing. The remaining balance is due 60 days prior to the event.

Securing Your Preferred Artist & Wedding Date

We do not reserve artist availability or wedding date until a signed contract and retainer is received.

Travel Expenses

- Travel expenses vary depending on location and number of artists.
- Hotel accommodations are required for Blush artist(s) on the night before the wedding when travel is more than two hours one-way.
- All Martha's Vineyard/Nantucket/RI weddings require accommodations the night before the wedding.
- Blush will handle hotel booking and room fee will be applied to the final balance.

Additional Artist Fee

If you choose to have an additional artist for a wedding party with fewer than 6 persons, an additional artist fee of \$300.00 applies.

On-site Artist Fee

If you require an artist to stay on-site, a \$150.00/hour fee applies. Vendor meals are provided by the bridal party.

Exclusivity Clause

Blush artists do not work with other makeup artists, companies, or counters. By contract, Blush reserves the right as the exclusive makeup artist to the entire bridal party.

Trial Consultation

- We will accept an appointment for a trial without a signed contract and retainer; however, we cannot guarantee your preferred makeup artist or wedding date.
- Trials without a signed contract and paid retainer are billed at \$200 per hour.
- We do not book wedding makeup trials for rehearsal dinners or engagement photo shoots.
